## DEFINITIONS

This Order shall be construed in accordance with the following Orders and/or Definitions:-

1. The Second Claimant shall represent the Officers and employees of the First Claimant, Invesco (as defined below), its clients, suppliers and service providers (as defined) pursuant to CPR 19.6.
2. Greg Avery shall represent the members of the unincorporated association Stop Huntingdon Animal Cruelty ("SHAC") conducting activities against the Claimants pursuant to CPR 19.6.
3. In this Order:
  - 3.1 "**Harass**" has the same meaning as in the Protection From Harassment Act 1997 ("the Act").
  - 3.2 "**References**" to "he", "him" or "his" shall be taken as meaning "she", "her" or "hers" where appropriate.
  - 3.3 "**Exclusion Zone**" shall mean any areas in which Protesting Activities (as defined in paragraph 5.8) are prohibited or curtailed by this Order or otherwise.
  - 3.4 "**Designated Protest Area**" ("DPA") shall be the area marked as such and delineated in blue on Plan A annexed hereto.(Plan A)
  - 3.5 "**Leafleting Zones**" shall be the two areas shown in hatched black on Plan A.
  - 3.6 "**Invesco**" shall be defined as Invesco Ltd and its subsidiaries, group companies and affiliates worldwide, including, for the avoidance of doubt, Invesco UK Limited.
  - 3.7 "**Client**" shall mean any third party to which the First Claimant provides investment services, directly or indirectly, such as investment advice or investment management.
  - 3.8 "**Supplier**" shall mean any third party that directly or indirectly supplies any goods to Invesco.
  - 3.9 "**Service Provider**" shall mean any third party that directly or indirectly provides any services to Invesco.
  - 3.10 "**Defendant**" or "Defendants" shall mean:

- 3.10.1 the members, participants or supporters of SHAC whether by themselves, their servants, agents or otherwise;
- 3.10.2 any person who is acting in concert with any of the Defendants to do any act prohibited by this Order and who has notice of the terms of this Order whether by himself, his servants, agents, or otherwise;
- 3.10.3 any other person who is protesting against:
  - 3.10.3.1 the conduct of experimentation on live animals by Huntingdon Life Sciences ("HLS");
  - 3.10.3.2 the business relationship between Invesco, its clients, suppliers and service providers and any animal research organisation (as defined by s.148 Serious Organised Crime & Police Act 2005);
- 3.11 Protected Persons shall mean any of the following while in England and Wales:
  - 3.11.1 the Second Claimant;
  - 3.11.2 the officers and employees of the First Claimant and of Invesco;
  - 3.11.3 the employees and shareholders of Invesco's clients suppliers and service providers;
  - 3.11.4 the families, servants or agents of the employees and shareholders referred to above;
  - 3.11.5 any person other than a Defendant who is seeking to visit any premises referred to in this Order, or any premises or home belonging to or occupied by any Protected Person.

## **THE ORDER**

**UPON HEARING Counsel for the Claimants**

**AND UPON HEARING Ms Debbie Vincent, an interested party**

**IT IS ORDERED that there be summary judgment for the First and Second Claimants in their claims against the First and Second Defendants**

**IT IS FURTHER ORDERED, until further order of the Court, that:**

- 4.1 The Defendants be restrained from pursuing a course of conduct which amounts to harassment of the Protected Persons within the meaning of the Protection from Harassment Act 1997.
- 4.2 The Defendants be restrained from entering any premises owned or occupied by Invesco, including but not limited to the premises of the First Claimant at 30 Finsbury Square, London EC2A 1AG.

**AND**

5. In particular and without prejudice to the generality of paragraph 4, the Defendants be restrained under Section 3 and 3A of the Act from doing, causing, permitting, encouraging or assisting any of the following:
  - 5.1 assaulting, harassing, molesting, threatening or otherwise interfering with any Protected Person;
  - 5.2 photographing or videoing any Protected Person, or his vehicle or any premises or house belonging to or occupied by any Protected Person or otherwise recording registration details of Protected Persons vehicles (save that, for the avoidance of doubt, Protestors may photograph or video each other and Police Officers).
  - 5.3 Making:
    - 5.3.1 any abusive or threatening communication whether orally, by telephone, in writing, by facsimile, by email or other electronic means to any Protected Person which shall include repetitive telephone calls, facsimiles, social network communications or emails;
    - 5.3.2 any communications whatsoever to any Protected Person at their homes, or on their private telephones, emails or social networking sites.
  - 5.4 Knowingly entering onto, remaining on or trespassing on any premises or home belonging to or occupied by any Protected Person.

- 5.5 Knowingly picketing, demonstrating, loitering or conducting any other protesting or protesting related activities:-
- 5.5.1 within 100 metres of any premises occupied as a home by any Protected Person;
  - 5.5.2 in relation to the First Claimant's premises at 30 Finsbury Square, London EC2A 1AG, in the exclusion zone marked in red on Plan A annexed hereto, and other than in accordance with the provisions set out in paragraph 5.9 to 5.12 below.
- 5.6 Publishing or procuring publication by any means whatsoever whether directly or indirectly by a third party publisher acting as agent or otherwise names, addresses, telephone numbers, fax numbers, email addresses, car or other vehicle registration numbers or any other material serving to identify a Protected Person or to publish his personal details.
- 5.7 Inciting, compelling or coercing any Protected Person against his will from doing something he is entitled or required to do or to do something that he is not under any obligation to do.

**SAVE THAT**

- 5.9 Demonstrations (including leafleting) in relation to the First Claimant's premises at 30 Finsbury Square, London EC2A 1AG may be conducted once every week in the following terms namely:
- 5.9.1 the number of Protestors present at such demonstrations shall not exceed 22 individuals (including 2 leafleters); and
  - 5.9.2 the maximum duration for all demonstrations (including leafleting) shall not exceed 2 hours; and
  - 5.9.3 subject to 5.9.4, demonstrations may only occur within the DPA marked and coloured blue on the Plan A annexed hereto; and

- 5.9.4 Two protestors may hand out leaflets in the Leafleting Zones. Leafleting may only occur within the Leafleting Zones, and is limited to one leafleter in the north Leafleting Zone and one in the south Leafleting Zone.
- 5.9.5 the Defendants may enter the exclusion zone for the sole purpose of gaining access to the DPA and the said Defendants shall place any banners, placards or signs which may be carried by them solely within the DPA without obstructing pedestrians, or distracting or obstructing drivers; and
- 5.9.6 the Defendants shall not park their vehicles within the boundaries of the exclusion zone except in cases of emergency other than in marked car parking spaces specifically allocated to members of the public; and
- 5.9.7 the Defendants may not use any instruments whatsoever (whether or not so designed) for the making of artificial or musical noise or to amplify sound including loud hailers; and
- 5.9.8 the Defendants may not wear balaclavas or face coverings (save for the purpose of adhering to genuinely held religious convictions or in prevailing cold weather), masks and/or blood splattered clothing or costumes; and
- 5.10 Not less than 24 hours before any proposed demonstrations, the Defendants shall have first notified the Police by telephone (during office hours Monday-Friday between 9am-5pm) and email and also to the Claimants by email and telephone as follows:

5.11 When notifying the police in accordance with sub-paragraph 5.10 above the Defendants must include the name of the group or groups that intend to take part, the registration number of any vehicles, the proposed number of Defendants, the site, the proposed start and end time of any protest, and a contact telephone number for the notifier.

**IT IS FURTHER ORDERED THAT:**

6. This Order is binding on all Defendants pursuant to CPR 19.6(4)(a).
7. There be substituted service of this Order herein on the Defendants by sending the same by pre-paid ordinary first class post in sealed envelopes addressed to:
  - 7.1 Stop Huntingdon Animal Cruelty ("SHAC") at 89 Bush Road, East Peckham, Tonbridge, Kent TN12 5LJ and BM SHAC, London WC1N 3XX;
  - 7.3 Greg Avery [A4874AD] HM Prison Coldingley, Shaftsbury Road, Bisley, Woking, Surrey GU24 9EX;
8. There be substituted service of this Order by exhibiting the same on posts within the exclusion zones.
9. There be substituted service of this Order by posting copies of the same on the website [www.shac.net](http://www.shac.net) on terms that SHAC is ordered, within 5 working days of receiving a copy of this Order in electronic form from the Claimants' solicitors, to place and maintain copies of this Order on the above website or any further websites created or controlled by it and to take all steps necessary to bring the same to the attention of their members or subscribers and to the attention of the Protestors referred to in this Order. In particular Greg Avery is ordered to use his best endeavours to ensure that copies of this Order are placed on the website referred to above.
10. The Claimants, Defendants and any party affected by this Order may apply to the Court at any time to vary or discharge this order but if they wish to do so they must inform the other party in writing at least 7 days beforehand except in case of emergency.

11. The Records of the Court in this action shall be limited to redacted material and shall not include any un-redacted material
12. No orders as to costs.

### **THE EFFECTS OF THIS ORDER**

- I A Defendant who is an individual who is ordered not to do something must not do it himself or in any other way. He must not do it through others acting on his behalf or on his instructions or with his encouragement.
- II A Defendant which is a corporation and which is ordered not to do something must not do it itself or by its directors, officers, employees or agents or in any other way.

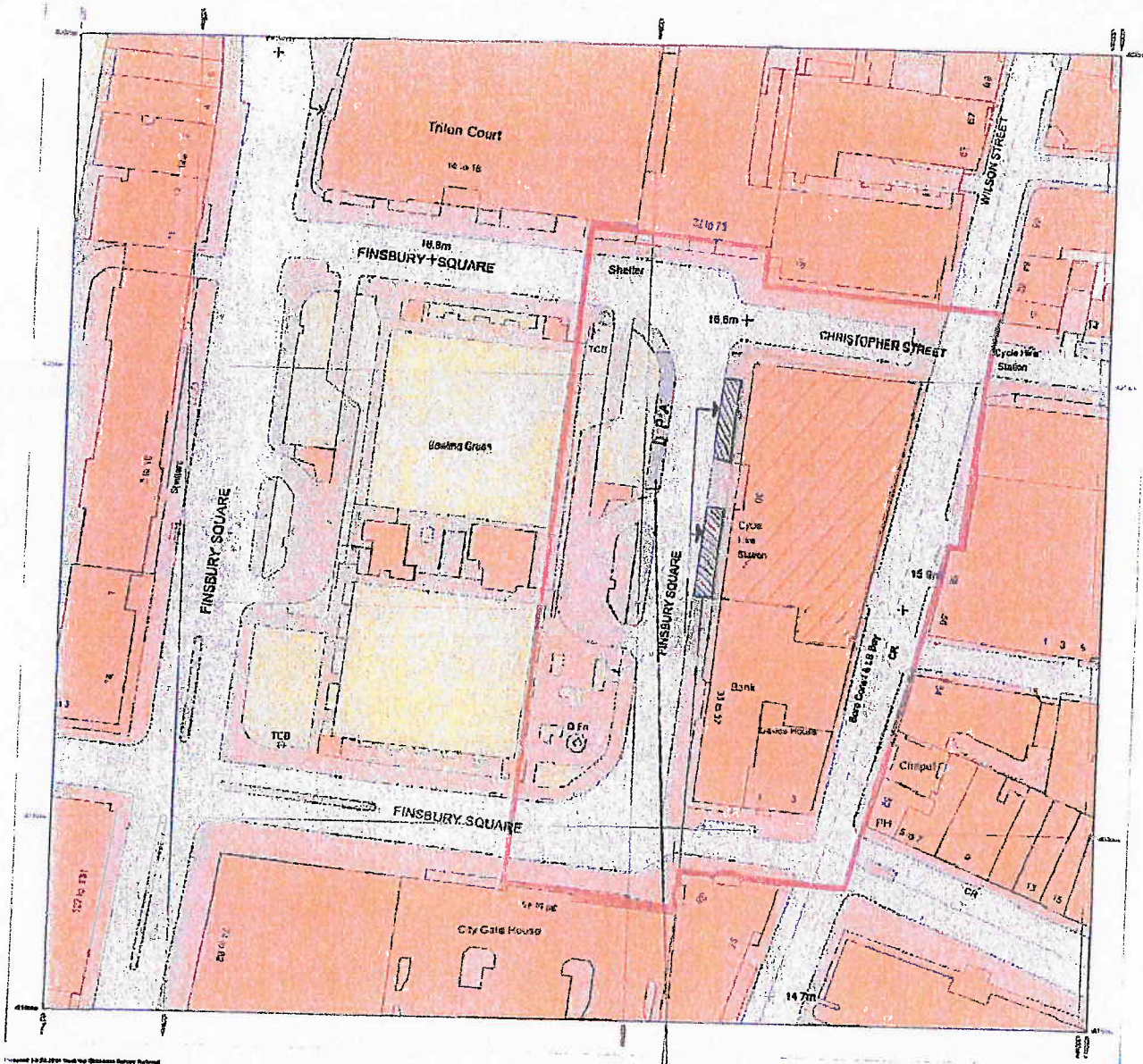
### **INTERPRETATION OF THIS ORDER**

- III In this Order, where there is more than one Defendant, (unless otherwise stated) references to "the Defendant" means all of them.
- IV A requirement to serve on "the Defendant" means on each of them. However, the Order is effective against any Defendant on whom it is served.
- V An Order requiring "the Defendant" to do or not to do anything applies to all Defendants.

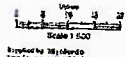
